ENTRY ROUTES

◆ **Minimum entry**

The minimum entry requirements are two A Level passes plus 3 GCSE passes in five separate subjects (including English and Mathematics) or equivalent, or a minimum average grade of C+ in KCSE(grade C or above including English and Mathematics) . Holders of higher qualifications may attract exemptions from some of the ACCA examinations.

◆ **Exemptions for degree holders**

Students with non-relevant degree may be exempt from some papers in the Fundamental Level and those with relevant degree from an accredited institution may be exempt from all nine papers in the Fundamentals Level.

◆ **Access ACCA via FIA qualification**

Minimum age 16

No academic qualification required

Student can opt to complete Foundations in Accountancy (FIA) Diploma first and then transfer to the skills module of the ACCA qualification by claiming exemption from the first three papers in the Knowledge module.

To qualify for Oxford Brookes, ACCA students need to meet the English Language requirements before sitting for F7.

What do you need to do in order to gain ACCA membership?

To qualify as an ACCA member you will need to complete:

- ◆ 14 exams (nine of which are eligible for exemption)
- ◆ Three years relevant practical experience
- ◆ Professional Ethics module

You can take a max of 4 papers every six months consecutively, combining it with working experience, it can take you 3 to 4 years to become an ACCA member.

FIA SUITE OF AWARDS

The FIA qualification consists of Introductory Certificate and Intermediate Certificate in Financial & Management Accounting and Diploma in Accounting and Business. The CAT qualification is achieved by passing all the levels and 2 optional papers, plus one year practical experience. All the papers are designed to test the knowledge and understanding you will need to work in accounting support roles. A basic illustration of the syllabus structure is provided below:
